MAKING ENDS MEET

- For 2026, NSHD received a 4.14% (the highest allowable increase in the Intergovernmental Agreement.
- Currently waiting on funding from Milwaukee County (CDBG, Community Paramedic) to ensure full funding for case management.
- All PHEP dollars, previously decreased, have been awarded.
 For NSHD, that's \$52K
- Applying for capital improvement funds from the River Hills Foundation

MAKING ENDS MEET

- 2 large DNR contracts have been awarded to SW and WFB DPWs for Lead Service Lateral Replacement Outreach Grant NSHD wrote (\$150K each)
 - Funding started 11/1/25 and goes through 10/31/27
 - OHIRED A Full Time Environmental Health Specialist for the role, and NSHD will charge \$24K in admin
- Village of WFB provided \$10K supplemental funding to NSHD, and with that we are able to keep our LTE RN 16 hours a week
- NSHD serving as fiscal agent for a \$400K grant for innovations in the Southeast Region. \$40K will be charged for the administration of that grant.

Marisa asked if Shorewood was doing the lead project already. And asked what the innovations grant is. Chris P asked what the parameters of the Innovation grant were. Chris P asked how the Shorewood board meeting went. Dr. Jay wanted to know what Becky thought was different with the WFB meeting vs the SW meeting and why WFB gave the HD money.

FINANCIAL OUTLOOK

- Slated to end 2025 with a budget surplus
 As of 11/17 we spent 68% of our 2025 budget and are 88% through the year
- Received our first grant (\$5K) through the Herb Kohl Foundation for the North Shore Health Department Foundation.
- NSHDF is written into an AHW grant that was recently moved to the next phase
- PHN Supervisor left (moved to NC) in August, and I hired a junior staff who started 11/10/25. Cost savings here.
- Historically funded grants are coming through and are flat-funded.

Chelsea asked if the paperwork regarding the AHW grant will be distributed by the NSHD. Extra copy of paperwork should go to their primary. Charonda suggested to offer help to fill out the paperwork.







Opioid Education and Naloxone Distribution

- •64% increase in distribution when comparing Jan November 2024 to 2025
- Over 500 people naloxone trained!35% increase

- NarcanDIRECT 2026 grant awardees:
 - •Continue to build partnerships: NSHD is now the supplier of naloxone to 5 North Shore Police Departments the other two are grant recipients. We are trying to learn more about this so we can work together with them.
 - adding in a few boxes of Revive 3mg to evaluate its use in our community

Why 3 mg of Naloxone? (from Why 3mg of Naloxone? - Harm Reduction Therapeutics) TL;DR: RiVive® is a 3 mg naloxone nasal spray that reverses opioid overdoses, including fentanyl, by restoring breathing. The 3 mg dose is strong enough to be effective, while minimizing withdrawal symptoms, making it safe and easy for bystanders to use in emergencies. It's the lowest OTC nasal naloxone dose available in the U.S.

Full Details: Naloxone works by blocking opioid receptors in the brain, which allows the body to restore its own breathing once it is no longer able to receive the effects of opioids. At times, breathing may need to be aided by rescue breathing techniques administered by bystanders to an overdose, or emergency medical services personnel who arrive at the scene of an overdose, after naloxone is administered.


- RiVive® uses 3.0 mg of naloxone to reverse opioid overdoses, including fentanyl overdoses. Our 3.0 mg dose is based on the scientific literature supporting the efficacy of naloxone in opioid overdose reversals broadly¹, and the efficacy of both 2.0 mg² and 4.0 mg intranasal (IN) naloxone formulations³.
- Our decision to formulate RiVive with 3.0 mg of naloxone was based on extensive input from harm reduction experts, the long history of reversing opioid overdoses using 0.4 mg of intramuscular naloxone, and the desire to administer enough naloxone to restore spontaneous breathing⁴ without inducing full-blown acute opioid withdrawal.

- Low dose naloxone has less of a chance of causing problematic, precipitated
 withdrawal that can complicate the overdose reversal and potentially cause harm
 to the person who has overdosed, just as they are recovering from a near death
 experience.
- Although 2 mg naloxone nasal sprays are widely used in Europe, RiVive's 3 mg is the lowest OTC dose of nasal spray naloxone available in the United States.

NSHD MEDICAL SHARPS COLLECTION PROGRAM

- Launched Monday, November 3
- We already filled an entire shipping box and a half (~15-20 sharps containers)
- NSHD is registered with the DNR to be listed as an official sharps collection site

- We charge \$10 for 2-gallon container, \$5 for ¼-gallon container, and \$5 for processing fee of any outside container (sharps or approved detergent bottles)


