## October 12, 2022: Let's Help Babies Sleep Safely

October is Sudden Unexpected Infant Death (SUIDs) and Sudden Infant Death Syndrome (SIDS) awareness month.

Sudden unexpected infant death (SUID) is a term used to describe the sudden and unexpected death of a baby less than 1 year old in which the cause was not obvious before investigation (CDC). During sleep is when SUIDs often occur. In Wisconsin from 2015 to 2018, SUIDs comprised 16% of infant deaths (<u>Source</u>).

Parents and caregivers can help reduce the risk of SUID and SIDS by creating a safe sleeping environment. Follow these tips from CDC:

- Place your baby on his or her back for all sleep times—naps and at night.
- Use a firm, flat (not at an angle or inclined) sleep surface, such as a mattress in a safety-approved crib, covered by a fitted sheet.
- Keep your baby's sleep area (for example, a crib or bassinet) in the same room where you sleep, ideally until your baby is at least 6 months old.
- Keep soft bedding such as blankets, pillows, bumper pads, and soft toys out of your baby's sleep area.
- Do not cover your baby's head or allow your baby to get too hot. Signs your baby may be getting too hot include sweating or his or her chest feels hot.



### **BE AWARE: RAINBOW FENTANYL**

With Halloween quickly approaching, now is a good time to remind residents to be aware of treats given out in the spirit of the holiday. **Many individuals have allergies and/or dietary restrictions, so host and party goers, alike, should use caution at events.** 

PARENTS SHOULD ALSO BE AWARE OF A RECENT TREND IN THE U.S., TARGETING YOUNG AMERICANS: **RAINBOW FENTANYL.** According to the DEA:

- Fentanyl is a synthetic opioid 50 times more potent than heroin and 100 times more potent than morphine. Two milligrams of fentanyl, equal to 10-15 grains of table salt, is considered a lethal dose.
- Brightly colored fentanyl is being seized as pills, powder, and blocks that resembles sidewalk chalk.
- Every color, shape, and size of fentanyl should be considered extremely dangerous.
- DEA laboratory testing has not found certain colors may be more potent than others.
- Laboratory testing is the only way to know how much fentanyl is concentrated in a pill or powder.
