**Someone you saw on Thanksgiving test positive for COVID-19?** If they were infectious during the Thanksgiving gathering, you may be at risk of infection. A person is considered infectious two days before they develop symptoms. For example, if your friend or relative started having symptoms on Saturday, November 28<sup>th</sup> and then tested positive for COVID-19 in the days following, they were infectious starting on Thursday, November 26<sup>th</sup>. If you had close contact with someone that tested positive, follow these recommendations for 14 days after your last date of contact, even if you test negative during this period: <u>Next Steps: close contacts of someone</u> with COVID-19 (wisconsin.gov)

You are a "close contact" if any of the following situations happened while you spent time with the person with COVID-19, even if they didn't have symptoms:

- Had direct physical contact with the person (for example, a hug, kiss, or handshake).
- Were within 6 feet of the person for a total of more than 15 minutes in a single day.
- Had contact with the person's respiratory secretions (for example, coughed or sneezed on; contact with a dirty tissue; shared a drinking glass, food, towels, or other personal items).
- Live with the person or stayed overnight for at least one night in a house with the person.

**If you are sick**, you should remain in isolation for:

- At least 24 hours after you are free of fever without the use of fever-reducing medications and other symptoms have improved, and
- At least 10 days after the date you first had symptoms.
