## Alert – North Shore Health Department (NSHD) is currently vaccinating health care providers as part of Wisconsin's Phase 1A.

We were alerted that our appointment sign up link for these providers has been sent to individuals who do not qualify as 1A health care providers. NSHD is **not** currently vaccinating members of the general public. NSHD is working with organizations to identify 1A providers and directly contacting them to make appointments.

## COVID-19 VACCINE UPDATE

Wisconsin is currently in Phase 1A of vaccine prioritization. This includes frontline health care workers and long-term care facility residents and staff.

The North Shore Health Department is beginning to vaccinate Phase 1A this week. The Phase 1A vaccine clinics are by appointment only and are being made available to Phase 1A providers on a weekly basis. There is a limited number of doses at this time. If you are a Phase 1A provider on our list you will be contacted individually.
