If you are a Phase 1A organization that needs to be vaccinated, you can register online to help make a connection with a vaccinator.

NSHD Vaccine Clinics

The details of future NSHD COVID-19 vaccine clinics will be announced on a weekly basis based on the availability of vaccine supply. Once we receive confirmation of our vaccine supply from the Wisconsin Department of Health Services, we will send notification about who NSHD will be vaccinating during this week. <u>Please do not contact our office to make an appointment or be put on a waiting list.</u> On Friday, January 29th we will send a notice out detailing how to sign up for clinics scheduled the week of February 1st. Notice will be sent through the North Shore Vaccine Updates email list and through our website when we know what our vaccine supply for the week will be.
