



# North Shore Health Department Public Briefing

January 28<sup>th</sup>, 2021 as of 4:15 p.m.

**NSHD Vaccine Update:** For the week of January 25<sup>th</sup>, NSHD received a very limited supply of COVID-19 vaccine, around 140 total doses. Our COVID-19 vaccine appointments are filled for this week. For the week of February 1<sup>st</sup>, we will know the availability of our vaccine supply by Monday, February 1<sup>st</sup> at the latest. Due to anticipated supply constraints, NSHD will only be vaccinating a limited number of eligible individuals, including frontline health care personnel and adults aged 65 and older. We will know how many people we will be able to vaccinate when we hear of our allocation from WI DHS. We will send out information to this [North Shore Vaccine Notification List](#) about how eligible individuals can sign up for a vaccine appointment. People who sign up for an appointment are also committing to a second appointment at NSHD in either 21 days for Pfizer or 28 days for Moderna.

NSHD will continue to request COVID-19 vaccine from WI DHS on a weekly basis. We will continue to share information on when and how eligible individuals will be able to sign up for our clinics on either the Friday or Monday of the upcoming week.



### Where Can Those 65+ Get the COVID-19 Vaccine?

Starting January 25, those eligible can get the vaccine:

- Through your health care provider
- By checking the website or social media of your health care provider, pharmacy, or local health department to see if the vaccine is available
- DHS and local health departments are coordinating additional vaccination options

Other resources for information include your local Aging and Disability Resource Center or senior center.



### Patience

It will take time to vaccinate everyone. The population size for those 65 and older is 700,000 and Wisconsin currently receives ~70,000 first-dose vaccines per week from the federal government.

**Adults Aged 65 Years and Older:** On January 25<sup>th</sup>, [WI DHS](#) expanded COVID-19 vaccine eligibility to adults aged 65 years and older. Healthcare systems such as Froedtert, Ascension and Advocate Aurora are reaching out directly to their eligible patients. Health systems are encouraging patients to sign up with their mobile apps or through their MyChart account to receive information about vaccination appointments. Check the website of the health system your doctor is affiliated with to learn more about how they are reaching out to eligible patients. Health systems, like local health departments, also have a limited supply of vaccine, so it will likely take time for providers to contact all their eligible patients.
