NSHD will send out a link on February 23rd, 2021 at 10:00am to sign up for COVID-19 vaccine appointments for this week. With the high demand and limited supply, we expect these appointments will fill quickly. NSHD will only vaccinate currently eligible populations including:

- Frontline health care personnel
- Residents and employees in skills nursing and long-term care facilities
- Police and fire personnel, correctional staff
- Adults ages 65 and older
