Nicolet High School Vaccine Clinic on Saturday, March 20

University of Wisconsin - Milwaukee

UMW is holding vaccine clinics in the Wisconsin Room in the Student Union on campus. They have partnered with Aurora Health and the Milwaukee Health Department.

This includes Brown Deer and Glendale

The Federal Emergency Management Agency (FEMA) will arrive in Milwaukee on Monday, March 15 to assist with COVID-19 vaccinations at the Wisconsin Center. As a result, the Wisconsin Center clinic will be open to eligible individuals living and working throughout the region. Individuals meeting the eligibility criteria can sign up for vaccination appointments through the health department's scheduling portal and vaccine information hub at milwaukee.gov/covidvax.
