May 11th, 2020 Update on COVID-19 (as of 4:30 p.m.)

The Centers for Disease Control and Prevention (CDC), the Wisconsin Department of Health Services (WI DHS) and the North Shore Health Department (NSHD), along with other local health departments are responding to the COVID-19 disease outbreak caused by a novel coronavirus.

We are currently monitoring 20 active cases in the North Shore, and we are also providing active monitoring for high-risk contacts of confirmed cases. We have triaged and processed over 1,500 suspect cases and/or contacts and performed several large contact investigations. We are also managing several active cases in Milwaukee to assist the Milwaukee Health Department.

COVID-19 Testing Sites in Milwaukee: Walk up or drive up testing will be offered on Milwaukee's north and south sides - at the Midtown parking lot at 5760 West Capitol Drive, and at UMOS on 2701 S. Chase Avenue. Testing will take place between 8 a.m. and 8 p.m. seven days a week. You do not need to make an appointment and do not need to be showing symptoms to be tested. Governor Evers and WI DHS released Emergency Order #36: Interim Order to Turn the Dial: This order allows all standalone or strip-mall based retail stores to offer in-person shopping for up to five customers at a time while maintaining required social distancing practices. 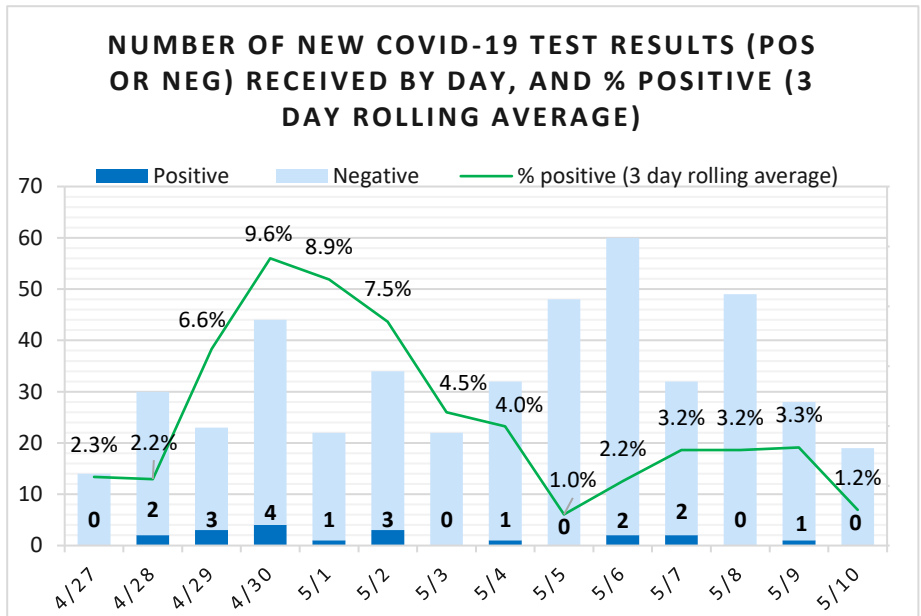

This graph displays the total number of positive and negative test results received per day in the North Shore, as well as the percent of test results that were positive (3 day rolling average). A total of 1,421 COVID-19 tests have been conducted in the North Shore as of 4:00 p.m. on May 11th. With a population of approximately 65,000 in the North Shore, this indicates that 2.2% of the North Shore population has been tested at this time. We especially encourage you to seek testing if you are experiencing symptoms of COVID-19, have been exposed to COVID-19, or are an essential or front-line worker.
