
The North Shore is currently in Phase C of the reopening plan: Businesses, organizations and residents should continue to follow the Phase C guidelines on our website.



This graph displays the total number of positive and negative test results received per day in the North Shore and the percent of test results that were positive (3 day rolling average). A total of approximately 5,313 COVID-19 tests have been conducted in the North Shore as of 2:00 p.m. on June 23rd. With a population of approximately 65,000 in the North Shore, this indicates that 8.2% of the North Shore population has been tested at this time.
