


## July 21<sup>st</sup>, 2020 as of 4:30 p.m.

Limit Gatherings and Social Events: The number of active cases of COVID-19 is continuing to rise within the North Shore every day, which could pose significant impacts on reopening plans throughout the rest of the year. The figure below shows a trend in the number of cases the health department is actively managing. Cases tend to be active and thus, in isolation for 10 days.



As the community continues to reopen, we ask that people limit social gatherings and events to minimize

the spread of COVID-19. These risk levels of spreading COVID-19 adapted from the CDC <u>website</u> are helpful when considering attending social events and gatherings:

Lowest risk: Virtual activities, events, and gatherings

**Medium risk**: Small outdoor in-person gatherings of individuals from same local area (community, city, county). Attendees remain spaced at least 6 feet apart, wear cloth face coverings, and do not share objects.

**High Risk**: Medium-sized in-person gatherings of individuals from outside of local area. Spacing allows for attendees to be 6 ft apart.

**Higher Risk**: Large in-person gatherings of individuals from outside of local area. Spacing does not allow for attendees to remain 6ft apart.

**COVID-19 Burden:** This table includes the COVID-19 case rate (burden) by community in the North Shore, as well as the overall burden in the North Shore. The burden measurement looks at the number of cases over the past two weeks per 100,000 people. Most of our communities are in high burden status, as over the past two weeks we have observed an increase in the number of new cases.

The burden status groups are set by WI DHS: WI DHS Burden Calculation Link.
