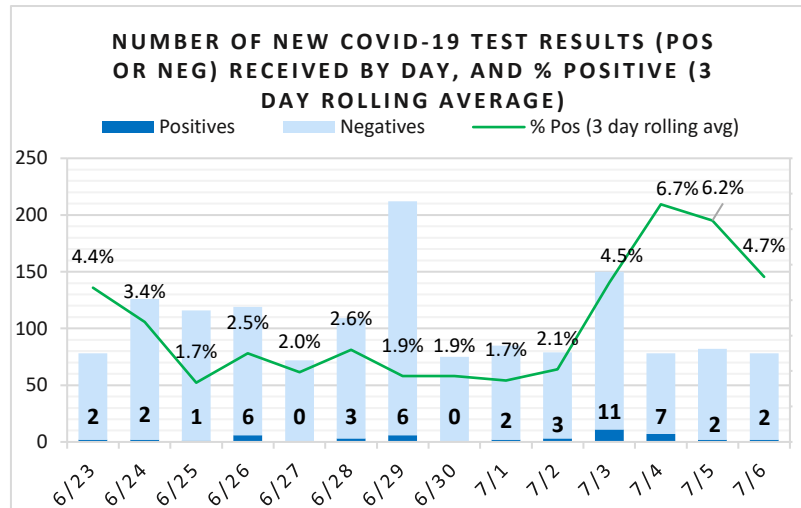

Cases Testing Care PPE Tracing



A total of approximately 6,773 COVID-19 tests have been conducted in the North Shore as of 3:30 p.m. on July 7th. With a population of approximately 65,000 in the North Shore, this indicates that 10.4% of the North Shore population has been tested at this time.
