We remind everyone to monitor for COVID-19 symptoms after the holiday weekend, especially if you were at a gathering or attended an event: You should monitor for symptoms for 14 days, as it can take up to 14 days for symptoms to develop. If you are experiencing symptoms, it is recommended that you self-isolate to avoid contact with others and seek testing.


