Is it safe to order takeout? CDC suggests that the risk of contracting COVID-19 from food is very low. As of right now, the main source of transmission is person-to-person via respiratory droplets that spread when someone is coughing, sneezing or talking. The CDC estimates the highest risk of contracting COVID-19 while ordering takeout would be from handling the packaging or bags the food was in and touching your mouth, nose or eyes. Some helpful tips on how to reduce your risk while ordering takeout:

1. Wash your hands for 20 seconds with soap and water after handling food packaging
2. Dispose of food packaging- plastic or paper bags
3. Put food on plate or in a bowl, taking it out of original container and dispose of container
4. Wash your hands again for 20 seconds with soap and water after handling containers
5. Use your own utensils
6. Continue practicing other food safety guidelines
